Pharmacy Updates for July

Optum Rx has announced the July 2024 updates to the Premium Formulary. The formulary review process focuses on:

- Removing drugs from coverage that are less clinically appropriate, and often higher in costs, than covered products.
- Adding drugs with superior clinical efficacy to coverage.

Impacted Culinary participants were sent a letter informing them of the change during the week of May 1st, 2024. An updated formulary booklet will be posted on the Culinary Health Fund website (<u>www.culinaryhealthfund.org</u>).

This update for July 2024 resulted in the following drugs being moved to excluded status*:
